1. Feature Description, Integrity, Eligibility:

This feature is a one room prairie school on a concrete foundation. The gable roof has shreds of wood shakes. There are several holes in the roof. The chimney is gone, soffits were closed. The building measures 16 feet east to west and 28 feet north to south.

The siding begins with a rake board under the eaves at the peak ends. The remainder of the siding is 6 inch wood lap. Corner trim is gone. There are openings for windows on the east side (5), north side (2) and south side (2), no glass and little framing. A door opening is on the south side as well. The walls in the building show lathe with the plaster gone. The ceiling had pressed tin tiles and about half of that has fallen in. The floor is tongue and groove hard wood with remnants of grain as the building was used for grain storage. There is wainscot on the walls of the entry. No evidence of electricity and no blackboards.


