The feature is a one room prairie school. Foundation unknow since we did not enter this farm yard. The gable roof of the school is covered with wood shakes and the entry has asphalt shingles. The chimney is gone. The soffits are closed.

There is a wide trim board under the soffits at the peak ends of the school with the remainder of the siding 6 inch wood lap with 4 inch wood corner trim. There is broken wood door at the entry. There are two small fixed glass windows to either side of the entry door. One double hung, two over two, window is on the west wall and there are three more on the east wall, glass intact. Wiring going to the building suggest electricity.

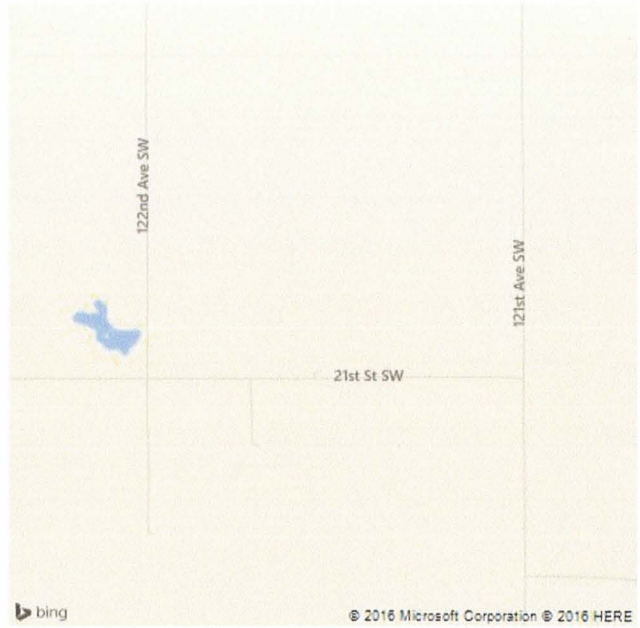
