1. Feature Description, Integrity, Eligibility:

The feature is a one room prairie school moved to a farm site and placed on concrete blocks. The gable roof is covered with asphalt shingles on the north slope and wood shakes on the south slope. The half hip roof of the entry is nearly bare of wood shakes right down to the roof boards. There is a tired red brick chimney at the peak of the roof near the west end. Cement has been used to do some patching. There is metal capping and finials on roof peak and ridges. The soffits are open.

A rake board begins the siding under the peaks of the main body of the school and under the overhang on the entry to continue with 6 inch wood lap and 6 inch corner trim. Some of the horizontal boards are falling off the school. There are three, four over four double hung windows, with remnants of window shades, on the south side with some glass, there are two more of the same windows on the north side. Most of them are covered. There is a sliding door that was installed at the west end of the north wall to give access for storage/shop. The entry has two windows, two over two, double hung on either side of the entry door on the east. There is a broken 4 panel door for access into the entry. The entry is full of broken lumber and other items. It looks like the ceiling fell into the entry shed. The walls of the entry have been stripped to the studs. The entry itself is separating from the main school room. The floor of the main room of the school is hard wood. The walls and ceiling are partially covered with wallboard, some is broken and is falling away. The walls and sloped ceiling are painted yellow with wainscot painted teal blue. There is one blackboard on the north half of the west wall with some framing for another at the south half of the west wall. The wall on the south side to either side of the west most window had blackboards. One of the spaces between two windows has a chalk tray with no slate above it. Wiring and an electrical outlet on the north wall would suggest the presence of electricity at some point.


