1. Feature Description, Integrity, Eligibility:

The feature is a one room prairie school moved to this location and placed on a concrete block foundation. The foundation has been skirted with wood. The hip roof is covered with asphalt shingles. The chimney is gone. The soffits are closed. The building measures 32 feet east to west and 28 feet north to south.

The siding begins with a rake board on all sides under the eaves. The remainder of the siding is 6 inch wood lap with 6 inch wood corner trim. The half hip roofed entry is a bumpout on the west side. Wood steps lead up to a 3 panel wood door with the window opening boarded up. The door from the coat room into the school proper is missing. There is a small, decorative fixed pane window on either side of the door. Also on the west wall are two more covered windows. They are fixed 4 pane windows and these are located in the coat room. On the east side there are 4 windows, three over one, some covered and some with glass. Two similar double hung windows are located on the south side, one covered and one not. The ceiling and about 2 feet at the top of the walls are covered with perforated acoustic tiles. The remainder of the walls are finished with lathe and plaster. There is a small blackboard located on the north wall. The floor is tongue and groove hardwood. Light fixtures are indicative of electricity. The heat was coal.

The school began in the late 1880's and closed in 1951. It was originally located a few miles west of Bottineau. The school is used for storage today.
