1. Feature Description, Integrity, Eligibility:

The feature is a one room prairie school that was moved to its present location when Cedar and Grant Township schools consolidated because of low numbers of pupils. The school came from SE of the present location and was originally a Cedar Township School. There are no closing dates available for Cedar Grant School. This building sits on a bit of a rise with prairie grass around it. The building is in good shape with asphalt shingles on the roof of the school. Shakes cover the roof of the entry. There is a metal ridge cap on the entry, none on the main body of the school. The slope of the entry roof was continued over an addition to the west that protects a stairway to the basement. There is a stove pipe runnning up the west side of the school for furnace venting. A wide trim board runs just under the open soffit around all four sides of the school. Electrical wiring can be seen on the west side of the school. The siding is 6 inch wood lap with metal corner trim. There is a bank of 6 windows on the east side of the school, all newer double hung windows. A double hung window in the entry appears to be original. The entry door is 5 panel wood door as is the entry door to the stairway to the west of the school entry. The foundation is concrete block with windows on the east and west sides of the basement. There was living guarters for the teacher in the basement of the school. The entry is reached by climbing poured concrete stairs with a railing on the left. Inside the entry of the school there is beadboard covering the walls and ceiling. The main body of the school has hard wood floor and lathe and plaster walls. Wallboard covers the ceiling. There is a grate in the middle of the floor. There is wainscoting under the blackboards and on the south wall. Flourescent light fixtures on the ceiling and blackboard on the west wall. At the northeast corner of the room there is a small closet with shelves for books and storage. In the northwest corner there is a door that leads to an interior stairway to the basement. Two rooms make up the basement with wallboard and concrete blocks. There is an opening in the south wall of the first room with a counter leading me to think it was probably used as a lunch room. No evidence of living space is left at this time. Another space was most likely used for fuel storage before they converted the furnace to fuel oil.


