1. Feature Description, Integrity, Eligibility:

The feature is a one room prairie school on a poured concrete foundation. The roof of the school and entry are sparsely covered with wood shakes. There is metal capping on the school roof peak and the hips of the entry with one finial at the top of the entry. There is most of a yellow brick chimney located at the west end of the peak of the roof. The eaves are closed on the main part of the school and open on the entry. The school room measures 18 feet north to south and 24 feet east to west with the entry measuring 18 by 10 foot.

There is a frieze board running under the eaves on all sides of the school. The siding is 4 inch wood lap with 4 inch wood corner trim. There are two small window openings in the entry, one on the east side and another on the north. The south wall of the school has a bank of 5 window openings with all the glass gone, a bit of framing left and most of the bottom half boarded up. There is one window opening on the north side. The walls and ceiling of the school room are finished with a combination of lathe and plaster and some wall board. The entry walls are open to the outer boards. There is a 5 panel wood door into the entry, no door into the school room. Waniscot is on part of the walls, perhaps removed to be used somewhere else. The floor is tongue and groove hardwood. The blackboards are gone. No evidence of electricity. The school room was used for grain storage in the past.




