1. Feature Description, Integrity, Eligibility:

[2023] Feature 1 description from the 2011 site form does not need updates. However, a determination of eligibility was not included at that time.

This building does not retain integrity of location, setting, feeling, or association because it has been moved. Research in 2011 and again in 2023 has been unable to determine the original location of the school. As noted in 2011, a place where a bell tower might have sat is visible on the western roof. Holes have appeared in the roof as well. Much of the integrity of design, materials, and workmanship has also not been retained due to the removal of the bell tower and the general deterioration of the structure. For these reasons it is recommended not eligible for the National Register of Historic Places.

Feature 1 was previously recorded as part of the North Dakota Country Schoolhouse Project in 2011. Because the previous location cannot be determined and the current state of the building is in poor condition it has been recommended not eligible for the National Register of Historic Places.

An additional 14 structures were identified at the location of the schoolhouse and added to the site form. All of the additional structures are of common style and are in poor condition due to lack of use and the periodic flooding from the nearby slough. They have all been recommended not eligible for the National Register of Historic Places.





Figure 1. 32ML01250 Site Map

This school building is in the Sverdrup School District, on a farmsite. I have no idea where it came from, have not been able to talk with anyone who has knowledge of the school. 


