1. Feature Description, Integrity, Eligibility:

This building is a one room prairie school on a concrete basement. The gable roof of the main body of the school, the half hip at the south end and the half hip at the north end are all covered with asphalt shingles. There is concrete chimney near the peak of the roof on the west slope.

The siding is 6 inch wood lap with wood corner trim. From a distance, there are several double hung window openings. Two windows located on the east side, windows on both the north and south walls of the larger room, two windows on the east face wall of the south addition and three on the south wall of that same addition, one window on the east wall of the north addition and two more on the north wall of that same addition. A door on the north side leads into that addition and there is another door on the east wall of the south addition.

It was marked a school by the North Dakota Department of Transportation on their maps. I wonder if it might have later been expanded for housing.
