1. Feature Description, Integrity, Eligibility:

This school is a one room prairie school on a poured concrete foundation. The hip roof of the school and half hip roof or the southwest addition are covered with wood shakes with metal capping. There is a red brick chimney on the east slope of the roof. The soffits are closed with beadboard. The building measures 20 feet north to south and 30 feet east to west with the addition measuring 10 feet north to south and 12 feet east to west.

There is a wide trim board running just under the soffits on all side of the school. The remainder of the siding is 6 inch wood lap with 6 inch corner trim concluding with waterboard and one more trim board at the bottom of the walls. There are two large double vented glass windows on the north wall of the main room of the school. Other windows include a fixed pane windows on the south wall of the addition as well as a double hung, glass intact window on the east side of this room. One more double hung, intact glass, window is on the east wall of the school proper. The wood entry porch has rotted and fallen into a pile. A 4 panel wood door, with 4 small decorative windows across the top, leads into an entry/coat room area with a second door giving access to the school room. Another door in the entry goes to the south addition. There is a room along the east end of the building, accessed by a door near the north wall. The interior walls are finished with wallboard and there is wainscot on the lower third of the walls with a wide trim board to finish that. The ceiling is also wallboard with flourescent light fixtures. There are blackboards, one on the south half of the west wall and a larger one on most of the south wall. An old style telephone hangs on the wall next to that south blackboard. The floor is covered with tongue and groove hardwood under tile. Light fixtures and exterior wiring speak to electricity being present. An oil burning stove sits at the east wall of the school room.


