1. Feature Description, Integrity, Eligibility:

The feature is a large one room prairie school on a concrete and concrete block foundation. The hip roof of the main body, the half hip roof of the south addition, the porch roof and the gable roof of the entry are covered with asphalt shingles. A tower on the entry might have held a bell at one time but today is an enclosed tower with wood siding and a pyramidal roof covered with asphalt shingles. The soffits are closed with beadboard. There are eaves troughs and downspouts. The main building measures 32 feet east to west and 40 feet north to south without the entry and south addition.

There is a wide trim board on the exterior walls running under the soffits on all four sides as well as the gable at the east end. There is a decorative slant on the under the peak at the gable end of the entry roof that is inline with the soffits of the remainder of the school. The siding is 6 inch wood lap with metal corner capping and near the bottom of the wall there is another wide trim board with waterboard. The paint is quite new. On the north east corner there is an open porch with one support column. The steps and porch floor are wood. The ceiling of the open porch is beadboard. The locked entry door is a piece of plywood. The east addition is where the entry and coatroom is located. There are covered window openings, one on the west side near the south end, another on the south side to the right of that entry door, another on the east side near the south end and one more on the east wall of the entry. There is a covered opening on the south side of the entry that was used for fuel delivery. The south half of the entry stored coal. On the west wall there are 4 large glass block windows and two vented glass block windows. These would likely be replacements as glass block windows weren't available in the early 1900's. A small, four pane fixed glass window is in the south shed and the there are several basement windows protected by wire screening. The owner tells me the basement has a furnace but wasn't used for anything else. At the south end of the school there is a 5 panel wood door, reached up a flight of wood steps, with a transom above it. This leads into a small room that the teacher used to stay in. This building has one large room with blackboards on the north wall and the east wall of the entry. The floor is hardwood covered by tile. A light fixture above the south door and wires near the porch suggest electricity.


