1. Feature Description, Integrity, Eligibility:

The feature is a one room prairie school on a concrete foundation. The gable roof is covered with wood shakes with metal capping and finials. A yellow brick chimney sits at the peak of the roof at the north end. The soffits are open.

Siding consists of composition board over horizontal wood planking. The small addition on the southeast corner shows some wood lap where the composition board did not cover it. The addition is a small entry with a broken 3 panel wood door with three horizontal openings at the top that had glass at some point. There are window openings on the east wall of the school with framing and some glass. I did not get close as there were bushes growing right up to the wall of the school. I also did not go inside. A small window opening is at the southwest corner of the west wall. Another window is located on the south wall, some framing and no glass. Pictures inside this window show an entry area with wood plank walls. The floor is hardwood. The ceiling is finished with 12 inch square tiles and walls are beadboard.
