1. Feature Description, Integrity, Eligibility:

The feature is a one room prairie school on a concrete pillars, east and west side and down the middle, north to south. The hip roof has very few wood shakes on the roof planking and the planking is also quite compromised. There is metal capping on some of the hips as wella st the peak with one finial. The soffits are open and there is no chimney. The building measures 24 feet north to south and 18 feet east to west.

Wide trim boards runs under the soffits on all four sides. The remainder of the siding is 6 inch wood lap with metal corner caps. On the north wall of the school there is a fuel door. There is an entry without a door. The bank of 4 double hung window openings in the main body of the school have framing in two with no glass and the other two are covered with plywood. The walls are partially covered with lathe and plaster with a picture railing running around the room. The ceiling only has lathe, no plaster remaining. The building was used for storage, there is a beadboard half wall so part of the building could store grain. The floor is tongue and groove hardwood. No blackboards and no wainscot. Light fixtures would suggest electricity at some point. Wood pieces on the outside of the walls with heavy anchoring wires help hold this school together today.




