1. Feature Description, Integrity, Eligibility:

The feature is a one room prairie school sitting on a foundation of fieldstone, patched in places with cement. The hip roof was covered with wood shakes. There is some metal capping. Many of the shakes have blown off and daylight can be seen coming through the north roof slope. There is no evidence of a chimney. There is a dorner on the south slope of the hip roof and the front shows two windows openings. It looks like a bell tower may have been removed from the top of the dormer. The soffits are open. The building measures 21 feet east to west and 30 feet north to south.

A rake siding board runs just under the eaves on all sides of the school. The remaining siding is 6 inch weathered wood lap with 4 inch wood corner trim. On the south side of the school there is a door opening, the door has broken and is missing. A transom window opening is above the door. A coat room was located in the southwest corner just inside the door. There are also two double hung window openings with some framing and no glass. A bank of 6 double hung window openings run along the west wall, some framing is still there but no glass. The interior walls are lathe and plaster, some falling in. The ceiling has failing plaster as well. Wainscot runs along the walls. The floor is hardwood and there are holes. A frame is all that is left of the blackboard. No evidence of electricity.
