#### 1. Feature Description, Integrity, Eligibility:

The feature is two framed one room schools attached to make a two room school. It appears that a gable roofed school was moved to the west side of a hip roofed school and they were attached and roofed to enclose the opening. The buildings sit on concrete foundation. The roofing is asphalt with the gable roof of the western building tied into the west slope of the eastern, hip roofed building. There is a also an entry with a gable roof tied into the south slope of the east part of the building. There is a tall red bricked chimney on the north side, tucked into the corner where the two buildings meet. The chimney is entirely outside of the building and tied to the roof to keep it from tipping away. All eaves are have finished soffits. The north part of the building measures 16 1/2 feet north to south and 34 feet east to west. The south part of the building is 24 feet square with an 8 X 8 entry.

There are headers under the north peak of the school and around the existing sides of the eastern part. Also a header under the peak of the entry. Siding is 6 inch wood lap with 4 inch wood corner trim. Many areas show the underlying wood lumber where siding as fallen away or been removed. There are two sets of two double hung windows on the south wall of the north part of the school, most of the glass is broken. No windows on the northern part of the west end. On the east end there are two pairs of windows, glass broken, in the south facing wall, either side of the entry. Another window opening on the north side has no glass or framing. There is a door opening on the north side of the east part of the school. The east wall has two opening that were filled in with wood lap and perhaps were windows. The entry has a 5 panel wood door allowing entry into the school. On the east side of the entry is a covered opening that may have been a window. The flooring is hard wood tongue and groove. The walls are of different materials, paneling on most walls, wall board on others, wainscot is behind some of the paneling. There is electricity in the school and the heat was fuel oil.
