#### 1. Feature Description, Integrity, Eligibility:

Nash Township School is a one room prairie school sitting on a concrete foundation. The school bulding roof is mostly covered with wood shakes. There is metal capping running the length of the peak of the gable roof. A red brick chimney runs up the outside of the north side of the school. It appears to be a newer chimney than most and likely was added for use with the fuel oil stove located in the school. There's a wide trim board under the peak ends of the roof. All soffits are closed. Siding is 6 inch lap with 6 inch corner trim.

Three windows on the west side of the school are shuttered on the outside. Three more windows are on the east side and two of those are not shuttered. Some of the glass is missing but the frame work remains. The entry has one covered and one uncovered window, also without glass.

Concrete steps lead to the entry. A 5 panel wood entry door is still intact. The entry has room for coats and lunch boxes and etc. A 4 panel doors gives access to the school room. Walls are covered with wallboard on the upper 2/3 with wainscot finishing the walls on the lower 1/3. The wainscot and the entry are painted green with the other walls remaining white. The ceiling is also wallboard. There are lights on the ceiling, indicative of electricity. The floor is tongue and groove hard wood painted grey. There are blackboards on the north wall and between the north and middle windows on both side of the school room.

The school building measures 24 feet north to south and 16 feet east to west. An outhouse sits immediatly to the north of the school.




