1. Feature Description, Integrity, Eligibility:

The feature is a one room prairie school sitting on a poured concrete foundation. The school was moved to this location. The roof is covered with steel sheeting with steel ridge cap. There is a short, red brick chimney at the west end of the roof peak. The is also a new, metal pipe chimney running up the outside wall at the west end of the school.

The siding begins with a rake board under the peaks with the remaining siding being 4 inch wood lap with 4 inch wood corner trim. The entry is at the east side of the building. A 5 panel wood door with a transom window above it gives access to the school. The windows are two over two double hung, with glass. There are 3 windows on both the north and south sides. Two more similar windows are either side of the door at the east end. A light over the door at the east end of the school would indicate electricity at some point. There is a blackboard on the west wall of the school. Did not go inside this school to see walls and floor.
