1. Feature Description, Integrity, Eligibility:

The feature is a one room prairie school moved to its current location and placed on a poured concrete foundation. The gable roof is covered with metal sheeting. There is a cement chimney at the peak on the east end of the roof. The soffits are closed. There are cornice returns on the peak ends. The building measures 25 east to west and 33 north to south.

The siding is all vertical metal sheeting with metal corner trim. On the west end of the building a large overhead garage door has been installed. An entry door is located on the north side at the west end. Also on the north side are two 4 pane windows set high on the wall just under the eaves. One 4 over 4 double hung window is located on the east wall and it is completely covered by the metal siding. The windows on the south side have metal sheeting installed between each of three pairs of windows and along the top. They are similar to the window on the east wall but the lowest two panes have been covered up. A workbench runs along the window wall inside. The floor is cement. The walls are covered with pressed tin tiles. The curved ceiling is also finished with pressed tin tiles and these are of a different pattern than the walls. A coal burning furnace sits on the east wall. This building has electricity.


