1. Feature Description, Integrity, Eligibility:

The feature is a one room prairie school on a poured concrete foundation. The gable roof has failing wood shakes with remnants of metal capping. The yellow brick chimney has fallen into the school. The soffits are open. The building measures 16 feet east to west and 20 feet north to south.

The siding begins with a rake board under the eaves at the peak ends. The remainder of the siding is 6 inch wood lap with 6 inch wood corner trim. The door is missing. Two concrete and rock steps lead into the school. There are two double hung window openings on the east side as well as on the west side. Little framing and no glass remain in the windows. The interior has been completely stripped to the stud walls. The foor is tongue and groove hardwood with many holes. Electricity was present.


